Although e-transfers are preferred, we do accept cash or cheques. There is a \$50.00 fee for returned cheques.

REFUND/MAKE UP SESSIONS/PRORATING POLICY

- The club must be notified in writing by Friday October 10 2025 for Fall session cancellation of registration. Please note that the \$70.00 Skate Canada Fee is non-refundable. This cost has already been added to the registration fees. Winter program (Jan-Mar) cancellation date is January 23, 2026 (For those only signed up for that session)
- There is no refund after these dates except for medical reasons. A Doctor's note is required.
- There is NO refund of fees or prorating of fees if you are going to be away for holidays.
- There are NO make up sessions for missed dates due to sickness.
- There is no refund for weather-related cancellations as we do endeavor not to cancel unless the City of Cambridge closes its facilities.
- Prorating of fees is only done if registering after the first 3 weeks of the program has passed.
- **We ask that you keep your child home if they are sick.**

PRIVATE LESSONS

A private lesson is one-on-one instruction with a professional coach that supplements the skater's group time provided by the club. This is an optional service that some skaters use and that is open to all Starskaters. These lessons are an additional cost paid directly to the coach generally at the end of each month. Each coach has their own schedule and rates.

If you are interested in hiring a coach, either approach the coach your skater would like lessons from or ask the club for assistance. Please note, NOT all coaches that are on the ice can take privates.

1. I hereby irrevocably permit, authorize, grant, and license HSC and its members, affiliates, successors, agents, and assigns, and the employees, officers, directors, and agents of each and all of them ("**Authorized Persons**"), the rights to display, publicly perform, exhibit, transmit, broadcast, reproduce, record, photograph, digitize, modify, alter, edit, adapt, create derivative works, exploit, sell, rent, license, otherwise use, and permit others to use, my name, image, likeness, appearance, voice, and other personal characteristics, and all materials created by or on behalf of HSC that incorporate any of the foregoing ("**Materials**") in perpetuity throughout the universe in any medium or format whatsoever now existing or hereafter created, including but not limited to, in and on magazines, brochures and other print publications, electronic, magnetic, and optical media, motion pictures, broadcasts, the internet and other digital transmission or delivery methods, mobile applications, on any platform and for any purpose, including but not limited to advertising, public relations, publicity, and promotion of HSC and its affiliates and their services, without further consent from or royalty, payment, or other compensation to me.

2. HSC or its Authorized Persons shall be the exclusive owners of all right, title, and interest in and to the Materials, including all copyrights in perpetuity throughout the universe. I hereby irrevocably transfer, assign, and otherwise convey to HSC my entire right, title, and interest, if any, in and to the Materials and all copyrights and other intellectual property rights in the Materials arising in any jurisdiction throughout the universe in perpetuity, including all registration, renewal, and reversion rights, and the right to sue to enforce such copyrights against infringers. I hereby irrevocably waive all so-called "moral rights" in the Materials. To the fullest extent permitted by applicable law, I hereby irrevocably waive all legal and equitable rights relating to all liabilities, claims, demands, actions, suits, damages, and expenses, including but not limited to claims for copyright or trademark infringement, infringement of moral rights, libel, defamation, invasion of any rights of privacy (including intrusion upon seclusion, false

light, public disclosure of private facts, and misappropriation of name or likeness), violation of rights of personality or publicity, physical or emotional injury or distress, or any similar claim or cause of action in tort, contract or any other legal theory, now known or hereafter known in any jurisdiction throughout the world (collectively, "**Claims**") arising directly or indirectly from the HSC's or the Authorized Persons' exercise of their rights under this Agreement or the production, exhibition, exploitation, advertising, promotion, or other use of the Materials, and whether resulting in whole or in part by the negligence of HSC or any other person, covenant not to make or bring any such Claim against any Authorized Persons, and forever release and discharge the Authorized Persons from liability under such Claims. I understand that HSC is relying on this Agreement and will incur significant expense in reliance on this Agreement, and I agree that this Agreement cannot be terminated, rescinded, or modified, in whole or in part.

4. This Agreement constitutes the sole and entire agreement of the parties to this Agreement with respect to the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter. I have not relied on any statement, representation, warranty, condition, or agreement of HSC or of any other person on HSC's behalf, including any representations, warranties, conditions, or agreements arising from statute or otherwise in law, except for the representations, warranties, conditions, or agreements expressly contained in this Agreement. If any term or provision of this Agreement is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability will not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction. HSC may assign this Agreement and its rights hereunder, in whole or in part, to any party. This Agreement is binding on and inures to my benefit and the benefit of HSC and our respective heirs, executors, administrators, legal representatives, successors, and permitted assigns. All matters arising out of or relating to this Agreement shall be governed by and construed in accordance with the laws of Province of Ontario and the federal laws of Canada applicable therein without giving effect to any choice or conflict of law provision or rule.

Release of Liability, Waiver of Claims and Assumption of Risks

**BY SIGNING THIS DOCUMENT, YOU WILL WAIVE CERTAIN LEGAL RIGHTS,
INCLUDING THE RIGHT TO SUE OR CLAIM COMPENSATION**

PLEASE READ CAREFULLY!

IN CONSIDERATION OF Hespeler Skating Club ("**HSC**") permitting the individual named below ("**I**" or "**me**") to participate in HSC's skating and other related programs (the "**Activities**"), and for other good and valuable consideration, I agree to all the terms and conditions set forth in this agreement (this "**Agreement**").

1. General Assumption of Risk: I am aware and understand that the Activities involve elements of physical activity which may include certain risks, dangers and hazards, including but not limited to the risk of injury, death or property damage. I acknowledge that I am voluntarily participating in the Activities. I freely accept and fully assume any and all of the risks, dangers and hazards involved and the possibility of injury, death or property damage, whether caused by the negligence of HSC or otherwise.
2. Acknowledgement of Physical Contact: I acknowledge and agree that the Activities, including instruction, training, and other their components, will involve reasonable physical contact between myself and other participants, instructors of HSC, or other related parties and that should I have any discomfort, complaint, or other issue with such physical contact with any party, I will bring such complaint to the attention of the other party and shall endeavor to reach a reasonable resolution to address such issue. I understand and agree that should the parties not be able to reach a reasonable resolution, HSC retains the right to terminate my membership and that I waive and release any and all claims I may have against HSC and its representatives arising from such issue.
3. COVID clause: Without in any way limiting the foregoing, I am specifically aware of the highly contagious nature of bacterial and viral diseases including the 2019 novel coronavirus disease (COVID-19) (collectively, the "**Disease**") and the risk that I may be exposed to or contract the Disease by engaging in the Activities. I understand and acknowledge that such exposure or infection may result in serious illness, personal injury, permanent disability, death, or property damage. I acknowledge that this risk may result from or be compounded by the actions, omissions, or negligence of others, including HSC's employees. I understand that while HSC has implemented preventative measures to reduce the spread of the Disease, HSC cannot guarantee that I will not become infected with the Disease while participating in the Activities and that my participation in the Activities may increase my risk of contracting the Disease. Notwithstanding the risks associated with the Disease, I acknowledge that I am voluntarily engaging in the Activities with knowledge of the danger involved. I hereby agree to accept and assume all risks of personal injury, illness, disability, death, or property damage, arising from my engaging in the Activities, whether caused by the negligence of HSC or otherwise.
4. Waiver/Release/Indemnification: I hereby expressly waive and release any and all claims which I have or may in the future have against HSC and its members, its affiliates, and their respective directors, officers, employees, agents, representatives, shareholders, successors and assigns (collectively, "**Releasees**"), including but not limited to on account of injury, death or property damage arising out of

or attributable to my participation in the Activities, due to any cause whatsoever, including without limitation the negligence of HSC, its members, or any other Releasee, breach of contract, or breach of any statutory or other duty of care owing under occupiers liability legislation or otherwise. I covenant not to make or bring any such claim against HSC, its members, or any other Releasee, and forever release and discharge HSC, its members, and all other Releasees from liability under such claims.

5. Entire Agreement clause: This Agreement constitutes the entire agreement of HSC and me with respect to the subject matter contained herein and supersedes all prior and contemporaneous understandings, agreements, representations and warranties, both written and oral, with respect to such subject matter.
6. Severability: If any term or provision of this Agreement is held to be invalid, illegal or unenforceable in any jurisdiction, such invalidity, illegality or unenforceability shall not affect any other term or provision of this Agreement or invalidate or render unenforceable such term or provision in any other jurisdiction.
7. Successors and Assigns: This Agreement is binding on and shall enure to the benefit of me and my heirs and next-of-kin, and HSC and its successors and assigns.
8. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the Province of Ontario and the federal laws of Canada applicable therein. Any claim or cause of action arising under this Agreement may be brought only in the courts of the Province of Ontario, and I hereby consent to the exclusive jurisdiction of such courts.
9.
